European Academy of Allergy and Clinical Immunology (hereafter referred to as "EAACI") is the provider of the My EAACI portal.

# General Terms and Conditions for the My EAACI portal

These General Conditions herein are intended to define the conditions and procedures under which the portal and services offered on the portal are made available to the members and non-members of EAACI.

# **Membership types and Benefits**

### **EAACI Individual Membership**

Available to all clinicians, researchers and allied health professionals, dedicated to improving the health of people affected by allergic diseases.

### **EAACI Individual Membership**

Available to all clinicians, researchers and allied health professionals, dedicated to improving the health of people affected by allergic diseases.

### **EAACI Junior Membership**

Free membership available for individuals aged 35 or under who are scientifically or clinically interested in allergy and/or clinical immunology:

Possibility to apply for the Clinical Fellowship Award, Research Fellowship Award and travel grants to EAACI events.

When registering as an EAACI Junior Member, you must provide a copy of your passport for age verification.

#### **EAACI NAS Dual Membership**

The EAACI National Allergy Society (NAS) Dual Membership is available to all current members of a respective national society. Please note that the national society will have to confirm if the member is in a good standing. For this purpose, data are shared between EAACI and the National Allergy Society.

When registering/renewing as an EAACI NAS Dual Member, you must indicate which National Allergy Society you are a member of and fill-in your valid national society membership number.



### EAACI / AAAAI Dual Membership

All EAACI Members can benefit from a 20% reduction in the membership fee of AAAAI if they are a Corresponding Member. Vice versa, Members of AAAAI can join EAACI as Members and receive a 20% reduction on the full EAACI membership fee.

When registering/renewing as an EAACI/ AAAAI Member, you must provide a copy of your AAAAI membership certificate, a copy of your latest invoice indicating the expiration day of your current subscription and your AAAAI membership number.

### EAACI / ACAAI Dual Membership

EAACI offers a Dual Membership with a 20% reduction on the full membership fee to all members of the American College of Allergy, Asthma & Immunology (ACAAI).

When registering/renewing as an EAACI/ ACAAI Member, you must provide a copy of your ACAAI membership certificate, a copy of your latest invoice indicating the expiration day of your current subscription and your ACAAI membership number.

## EAACI / European Respiratory Society Dual Membership

The Dual Membership is open to all members of EAACI and the European Respiratory Society. Members will be entitled to a 30% discount on the full membership fee of the respective Society.

When registering/renewing as an EAACI/ ERS Member, you have to provide a copy of your ERS membership certificate, a copy of your latest invoice indicating the expiration day of your current subscription and your ERS membership number.

### EAACI / European Rhinologic Society Dual Membership

The Dual Membership is open to all members of EAACI and the European Rhinologic Society. Members will be entitled to a 10% discount on the full membership fee of the respective Society.

When registering/renewing as an EAACI/ ERHS Member, you must provide a copy of your ERHS membership certificate, a copy of your latest invoice indicating the expiration day of your current subscription and your ERHS membership number.



All the above membership types (except EAACI NAS Dual Membership) are eligible for discounts of the membership rates on registration fees to EAACI Congresses, Focused Meetings, Allergy Schools and the EAACI/UEMS Knowledge Examination.

## **Membership Fees**

Prices for the various membership subscriptions are available on the portal and EAACI website.

Membership fees are exempted from VAT.

An additional 7.7% VAT is applied on membership fees for Swiss residents.

EAACI Membership fee is based on the average per capita income of each country according to the World Bank Report. Members from a country with a GNP of less than USD 10,000 will receive a 50% reduction on the EAACI Membership fee, including full Membership benefits. ## Terms of each subscription

The term of each subscription starts from the registration/renewal date and ends on December 31 of the year in which the registration/renewal has been made.

Non-members who apply and pay for the EAACI membership after 1st October of the current year of the application, will have full membership status until 31st December of the following year (this doesn't apply for membership renewals).

### **Methods of Payment**

Payment is required at the time when registering to become a member or registering for an event by Credit card (Visa/Mastercard/American Express) in EUR. Registrants should complete all the mandatory fields.

After submitting your application, you will be transferred in our secure payment gateway.

# Letter of Confirmation/Payment Receipt

A letter of confirmation/payment receipt will be sent by email once the Membership Team has received the fully completed membership application or congress or event registration and the related payment.



# **Membership Cancellation Policy**

Notification of cancellation must be made in writing and sent to the Membership Team by email at <a href="mailto:member@eaaci.org">member@eaaci.org</a>. The notification must include all the relevant information to which a possible refund may be remitted (email address which has been used during the application or event registration).

A Member may terminate his/her membership subscription at any time by sending a notification Cancellation of Membership after 30 days. EAACI shall not entitle the Member for any refund, regardless of which party is responsible for termination (the third party or the Member himself/herself).

By terminate his/her membership, all applied membership benefits connected with an EAACI event registration will be disabled, as a result new registration fees will be applied in his/her registration of the corresponding event.

# **Membership Refunds**

Refunds will not be given to attendees who have already renewed and paid their membership and wishes to reclaim the voucher. Should this be the case, your voucher will be automatically used for your next subscription.

# Opting out, changing, or having your information deleted

At any time, you can modify your information by returning to the My EAACI portal and click on "Profile" to make any personal or professional details modification. Please be aware that EAACI may keep your personal details for financial requirements to evaluate payments and transactions made.

After successfully creating you're my EAACI account you will receive personal access details to access the portal.

Your access details are strictly personal and unique to your account, therefore must not be given to any other person.

#### **EAACI Goes Green initiative**

## **Fulfilment and Jurisdiction**

These General Terms and Conditions shall be subject to Swiss law. In the event of any legal claims arising from either party, Zurich, Switzerland shall be the sole court of jurisdiction.

# **Severability Clause**

If there is a determination of these General Terms and Conditions to be ineffective or impracticable, then the validity of the General Terms and Conditions remaining shall not be impaired.
